ARTICLES OF INCORPORATION  
OF  
PENINSULA HIGH SCHOOL BOOSTER'S CLUB

The undersigned, for the purpose of forming a corporation under the nonprofit laws of the state of Washington, RCW 24.03, states the following:

ARTICLE I

The name of the corporation shall be: PENINSULA HIGH SCHOOL BOOSTER'S CLUB.

ARTICLE II

The term of existence shall be: Perpetual.

ARTICLE III

The purpose for which the corporation is organized are as follows: To encourage, support and promote co-curricular student activities within the Peninsula School District, including, without limitation, sports, music, theater, debate and similar activities for students.

No substantial part of the activities of the corporation shall be devoted to the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE IV

The name of the registered agent of the corporation is: ROBERT LESLIE.

## ARTICLE V

There shall be not less than three (3) directors serving as the initial Board of Directors. Their names and addresses are as follows:

## ARTICLE VI

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all net assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Pierce County Superior Court, exclusively for such purposes or to such organization or organizations, as such court shall determine, which are organized and operated exclusively for such purposes.
